#### Thursday, September 15, 2016:

Chairman Schock called the meeting to order at 10:00 a.m. Chairman Schock asked for public comment and heard none.

Introductions were made and Chairman Schock asked for changes to the tentative agenda.

Director Myllymaki moved and Director O'Hara seconded the motion to approve the tentative agenda with changes. The motion passed unanimously.

#### Review of June 27, 2016 Meeting Minutes

Executive Vice President Collin Watters presented the minutes of the Summer Board Meeting.

Director Mattelin moved and Director Kolstad seconded the motion to approve the minutes with changes. The motion passed unanimously.

### **Financial Review**

Kolleen Spurgin presented the end of the fiscal year financials.

Director Mattelin moved and Director Myllymaki seconded the motion to approve the financials as presented. The motion passed unanimously.

### **Montana Department of Agriculture**

Kim Mangold reported to the board on the decrease in funding due to the drop in coal shipments, this effected Lori Brenneman's job with the department. She has moved to Idaho, but is working part time with her Ag Literacy program with the department.

The hail program has had a rough year with a 130% loss. Funding is being cut for the Agricultural Food Development Centers and they will start looking for additional funding from other sources. The Foreign Agriculture Service Attaches will be coming to town on September 16<sup>th</sup> for tour and dinner.

Greg Stordahl from the State Grain Lab talked about the reasons for the 2 week delay in the sampling of grain, they are in the process of training two more certified grain inspectors.

#### Fiscal Year and the Legislature

Executive Vice President Watters said the conversion to a calendar year budget is on track and should be complete by January of 2017. The Department of Agriculture submitted the request for one-time-only increase in spending authority funding to the Legislature for approval.

## <u>Transportation Report</u>

Cort Jensen gave the board an update on some of the transportation issues that he is dealing with, including the changes being made at the STB. The STB wants to change their comparison testing and how it is done. He would also like the Attorney General to bring forth remedies on behalf of the state. Cort will email a memo to the transportation committee with points in the next couple weeks.

# **District Reports**

Chairman Schock asked the directors for reports on production and yields in their districts. Most reported that winter wheat, barley and pulses were good crops, spring wheat was poor or hailed out.

#### **MSU Update**

Dr. Boyer updated the board on events taking place at the university, in November they will be having a summit for the ag stations for planning for the upcoming year, this will be just before Celebrate Ag Weekend.

Enrollment is up at the college and the Tech Transfer office has sold a variety of grain to Wyoming, a first test of the new system.

## **U.S. Wheat Associates**

Director Kolstad attended the meeting in Fargo and was installed as the Secretary/Treasurer on his way to the Chairman position in a few years. Right now they are working on an updated strategic plan.

### **U.S Grains Council**

Director Mattelin attended the meeting in Louisville, KY; he was selected to go on a Barley Mission to Colombia the first part of October, paid for by USGC. The topic of barley coming from Europe to Mexico was discussed. The Mexican Craft Brewer's Conference is set for November 3-5 in Mexico City.

# Missouri River Recovery Improvement Committee

Director Mattelin attended his last meeting with this organization in Omaha. The work of the committee has gone in different directions and his input is not needed.

## Field to Market Meeting

Director Mattelin attended the meeting in Washington DC; they are working on the metrics for a sustainability calculator. The next meeting will be in Atlanta.

#### **MSU Endowed Chair Advisory Committee**

Director Mattelin met with the committee and talked with Dr. Budak about the work he will be doing, he wanted recommendations on the varieties that he should run sequencing on. The board decided on Vida, Yellowstone and Warhorse as possibilities.

### **Wheat Marketing Center**

Executive Director Cooper from the Wheat Marketing Center gave an update on what were some of the activities at the center and some upcoming events. There will be some updating going on at the center to keep it current and relevant to the times.

#### **Program Manager Report**

Cassidy Marn talked to the board about the trade teams this year and the AB Field day she attended.

#### **Executive Vice President's Update**

EVP Watters attended the Legislative tour in Kalispell with MGGA, he expressed that it had value and maybe it could be expanded in the future. He attended a round table meeting in Canada with Deputy Director Mangold, where they met with officials from the Canadian government.

EVP Watters also attended the World Brewing Conference in Denver with Cassidy, they presented a poster regarding sustainability and it generated a lot of interest.
