**Rahr Malting:**

Recapped meeting/tour with Ron Volpi that took place in eastern Montana July 22<sup>nd</sup> and 23<sup>rd</sup>. Buzz will follow up with Ron to see if he needs any additional help from the Committee regarding logistics and contact with Gavilon. Will need to see if Rahr needs to be registered with Secretary of State and if bonding is necessary. Rahr is interested in contracting with around 10 growers to do a trial run next spring.

**U.S. Grains Council:**

Discussion of meeting in Montreal. Mark Seastrand will continue as Barley Sector Director and barley sector is focusing on Constellation Brands.

Buzz will be attending the Craft Brewers Expo in Mexico City September 3-6.

CCM is interested in hiring a barley expert to help develop their specification for US grown barley.

Mexican pet food industry is growing and that may be an additional outlet for U.S. barley. Also some discussion about food barley, export potential to China, and meeting with Jorge Avila of SAB Miller.

## **Alberta Feedlot Tour**

September 1-3. Main event would be the Ag Value dinner on September 2<sup>nd</sup>, but if a Director is able to attend the entire tour that would be great. Director O'Hara requested a full agenda and expressed interest.

## **Constellation**

Buzz—Eastern Montana experienced average or better yield and good overall quality.

Bruce—High protein, low plump

Mike—Early dryland harvest saw high protein, later stuff was better. Hockett is all making malt. Some areas saw 1.5-3 inches of rain and many non-Hockett varieties saw sprout damage.

Chris—High protein, some over 15%.

A general consensus that growers want to plant more barley.

Staff will get a hold of the committee in September for follow-up.
